

Lt. Gov. Denn, Sec. Landgraf & Sec. Bhatt Tour KSI. Group Sees Challenges Firsthand

On November 14, Delaware's Lieutenant Governor Matt Denn, Secretary of the Department of Health and Human Services Rita Landgraf, Secretary of the Department of Transportation Shailen Bhatt, and Director of the Division of Developmental Disabilities Services Jane Gallivan visited KSI to tour the facility and to learn more about the funding and operational challenges facing KSI and its transportation services. It was the second time Lt. Governor Denn visited KSI in the last year.

KSI continues to engage Delaware elected officials and agency directors to create greater awareness of our services provided to Delawareans with disabilities. We're especially emphasizing KSI's transportation costs, which topped \$2 million in Fiscal Year 2011. As time approaches for considering the next fiscal year's State budget, KSI will continue advocating for increased State funding.

KSI's private transportation services help save DART (Delaware Area Regional Transit) First State hundreds of thousands of dollars a year on specialized transportation costs, because our average trip cost is \$19 as opposed to the State's \$36 cost per trip. And 96% of the 214 participants we transport

daily are eligible to use DART services.

Considering the 102,877 total trips we provided participants in Fiscal Year 2011, that's an annual savings of \$1,748,909 KSI provided the State.

We thank Governor Jack Markell, Lt. Governor Denn, Secretary Landgraf, Secretary Bhatt and Director Gallivan for making time to see KSI personally and become part of this ongoing conversation regarding needed support.

Discover Bank Contributes to Participants' Comfort

In 2011, Discover Bank once again stepped forward to help KSI participants and staff live a little more comfortably. One frozen morning in March of 2011, KSI employees arrived to find a very cold Milford facility, the building's boiler having failed overnight. Thanks to the resourcefulness of our facility management staff, we implemented alternate solutions to make it through the rest of the heating season. However, purchasing a new boiler became an important priority.

While we were able to find a large part of the funds for the project, there was still a sizeable shortfall toward replacing the faulty equipment. But Discover Bank stepped up to the plate with a generous donation of \$29,000, making up the remaining difference needed for the new boiler

and keeping KSI's facility well-heated and safe for the hundreds of people it serves every day.

Discover Bank has been a consistent KSI supporter, sponsoring fundraising events and calendars,

making vehicle purchases possible—including our refrigerated truck—and even buying 250 new cushioned chairs in 2010 for participants to use. We are very grateful for their contribution toward our boiler replacement costs and their ongoing commitment to KSI and its mission. The Discover Bank's CRA Director Amy Walls and Greenwood Branch Manager Sherry Berman have truly been heroes for our organization, and we appreciate their support.

Longwood Foundation Donates \$300,000 to Support KSI Transportation

Recently, KSI gratefully accepted a \$300,000 donation from the Longwood Foundation to help support our transportation services to participants. The Longwood Foundation has been an important supporter of the organization in the past, having significantly contributed to a number of capital campaigns. KSI applied for a grant earlier in the year from the Foundation to help defray costs of replacing aging vehicles. The extremely generous grant awarded by Foundation President Thère du Pont will go toward purchasing new 15-passenger vans to upgrade KSI's fleet.

"The thing that impressed Mr. du Pont during his visit was the degree to which we were engaged with the participants we served, as well as how self-sufficient we have remained over the years," relates KSI CEO, B. Craig Crouch.

KSI's transportation services are the lifeline between our participants and the employment opportunities available to them. KSI transportation between participants' homes and work places, whether the Milford facility or community-based work sites, is the only way many of them could enjoy consistent access to these opportunities. Our vans and busses logged approximately 1,138,161 miles in Fiscal Year 2011, at a cost of more than \$2 million.

Because of increases in fuel costs, which ran us \$310,963.52 in Fiscal Year 2011, and other operational expenses, transportation services have run a deficit of nearly \$1 million during the last fiscal year. That creates a particular financial challenge for KSI, but the service's value far outweighs its difficulties. KSI transportation services allow us to provide more than 212,117 hours of community employment, in addition to more than 66,682

hours of paid facility work, resulting in \$1,810,275 in participant wages.

Dollar for dollar, privately provided transportation services like ours are far more efficient and cost-effective than public services. KSI saves the DART First State system more than \$1.7 million each year by providing those services to our participants who would otherwise depend upon DART transportation. It's because of this comparative benefit that KSI is seeking continuing and growing support for these services from governmental sources, foundations and private donors.

KSI is extremely thankful for The Longwood Foundation's contribution and we look forward to replacing several older vehicles in our fleet as a result of the funding.



A Family's Passion for KSI Helps Make A Difference

KSI Seeks Help Finding Community-Based Assessment Sites

Starting in 2012, KSI seeks to better meet the needs of those we serve by changing the way we provide the Comprehensive Vocational Evaluation services we've offered for many years. And to accomplish this, we need your help to find established worksites within the community where KSI staff members can perform one-day assessments.

The purpose of the Vocational Evaluation is to assess an individual's vocational aptitude, skills, interests, behaviors, attitude, productivity, strengths, growth opportunities, assistive technology needs and soft skills. Where in the past these four-week assessments were often completed at the KSI facility, they will now be completed in the community at work sites aligned with the person's employment goals. And instead of a four-week effort, the new Community-Based Assessments will require only three, one-day assessments involving on-site work and observation.

We currently have several established sites, but we need many more in order to offer assessment opportunities that match each individual's employment goals. Assessment sites could include production, child care, custodial, food service, retail, lawn care, construction, receptionist, volunteering, non-profits and a variety of different jobs. There would be no expense or liability for the host site. And each participant will be accompanied by a KSI staff member while they are being assessed.

From Bottles to Bags, KSI Gets to Work

KSI has been fortunate in the last several months to see an increase in facility-based contract work. Some older customers are coming back with new work, as well as new customers providing projects we've never produced before.

Coastal Brewing Company in Dover started utilizing KSI to pre-pack their empty bottles for certain seasonal brews into six-pack containers, and those containers into cases, to help streamline their production during filling. The brewery

kept KSI participants busy several weeks during the last quarter, preparing cases for a variety of products. It's a good fit for KSI employees and will be ongoing work for some time.

Former KSI customer New Process Fibre is a local manufacturer for which we hadn't done work for a few years. Recently, we priced projects to bag four and 50 items each, and the work came through. In November, KSI employees were hard at work completing orders for thousands of bags within aggressive turn-around times. Our large workforce made it possible to keep production constant and satisfy New Process Fibre's schedule.

We've seen more requests for contract pricing from a number of companies in the last few months, both for facility production and work crews, which is a good sign. Now is the time to remind your business peers that KSI is ready and able to perform any number of production tasks, including assembly, bulk mail, kit making, product rework, quality control, shrinkwrapping and many other services. 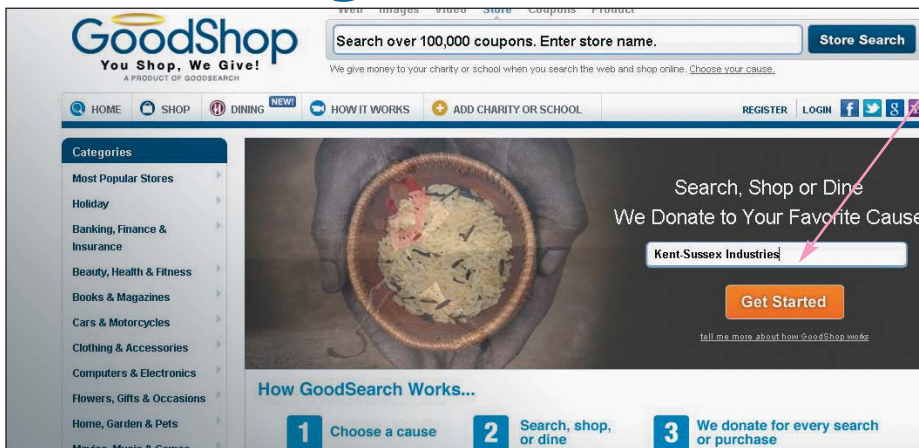

KSI Fiscal Year 2011 Annual Report

KSI is entering its 50th year serving the community, and we couldn't be more excited. Now more than ever, we're thankful for the dedicated participants, families, providers, board members, stakeholders, businesses, volunteers and staff whose tireless efforts through the last five decades have grown and sustained KSI in our mission to provide employment opportunities for persons with disabilities.

This year, we've made a concerted effort to engage Delaware's elected and appointed officials in KSI's future as well. Delaware's Governor Jack Markell, Lieutenant Governor Matt Denn, Department of Health and Social Services Secretary Rita Landgraf, Secretary of the Department of Transportation Shailen Bhatt, and others had the opportunity to personally tour KSI and understand some of the funding and support issues affecting participant services.

Nowhere was that need for support more evident than with KSI transportation services. KSI busses and vans traveled an amazing 1,138,161 miles providing participant transportation this past year. That extensive mileage represents a real funding challenge for the operation and maintenance of our transportation service. With that in mind, we are very grateful for The Longwood Foundation grant provided for the next fiscal year to help replace higher-mileage vehicles and bolster our transportation services.

As an indication of the growing momentum going into 2012, we

gained several new customers and saw many of our existing customers increase their utilization of KSI business services and KSI Cartridge Service. Total subcontracted income topped \$3.3 million, including both work crews and facility work. Additionally, our 22nd Annual 3 Club Golf Tournament raised more than \$21,000 to support KSI's programs, an increase over last year's event.

We saw strong performance from KSI Cartridge Service, selling more than 11,711 cartridges this past year to its customer base of 612 businesses and individuals. The Cartridge Service generated approximately \$782,373 in revenues. In a challenging economy, our compatible cartridge manufacturing operations managed to preserve much of its revenues over the previous fiscal year.

As we enter our next 50 years, our continued partnerships are crucial to KSI's effectiveness. Once again, we Thank the agencies, service groups, community groups, businesses and other partners that have generously supported and shown their confidence in KSI and the work we do. We also express our deepest appreciation for our program participants, staff and Board of Directors for the hard work you've done during the last year. KSI is about people helping people. And with these amazing people, we're able to provide those services so crucial to our participants' lives.

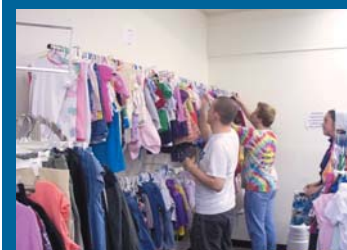
